環球晶圓股份有限公司（下稱「買方」）向來對於企業持續供應計畫採取最高標準，且期許所有供應商遵從持續供應計畫並建立標準；包含如遇天然災害(如:地震、火災、颱風、洪水、罷工..); 供應商應於災害發生 6hr 內進行通報;24hr 內提供詳細產線受損狀況及災變復工計畫;以符合持續供應的基本原則及預防供應鏈中斷之風險;鑒此，買方謹以此文件向所有供應商宣達此等信念。

GlobalWafers Co. Ltd. ("Buyer") is committed to comply with the highest level of Business Continuity Plan and expects all of its Suppliers to conduct Business Continuity Plan, including suppliers shall report the risk with initial damage situation to GlobalWafers Co. Ltd. within 6hr and provide report disaster recovery plan to GlobalWafers Co. Ltd. within 24hr (risks such as: earthquakes, fires, typhoons, floods, strikes), therefore to meet the Business Continuity policy and prevent the risk of interrupt from supplier chain.

地震 Earthquake (包括地震導致基礎設施毀損 Includes infrastructure disruptions caused by earthquake)	廠商工廠所在地區地震最大震度 5 級(含)以上時，無論有無災損都要通知。 Supplier shall notify customers of the situation when an earthquake of Magnitude 5 or above occurs locally, whether or not damage is incurred.
颱風/洪水(天災) Typhoon/Flood (Nature disaster) (包括颱風導致基礎設施毀損 Includes infrastructure disruptions caused by typhoon)	廠商工廠所在地區強烈颱風/洪水(天災)，無論有無災損都要通知。 Supplier shall notify customers of the situation when a strong typhoon/flood (nature disaster) makes landfall on the local area, whether or not damage is incurred.
火災 Fire (包括火災導致基礎設施毀損 Includes infrastructure disruptions caused by fire)	導致停工/停產影響產品交期時通知。 Supplier shall notify customers of the situation if it leads to production shutdown or suspension.
停電 Power Outage	導致停工/停產影響產品交期時通知。 Supplier shall notify customers of the situation if it leads to production shutdown or suspension.
停水 Water Suspension	導致停工/停產影響產品交期時通知。 Supplier shall notify customers of the situation if it leads to production shutdown or suspension.



關鍵及主要設備故障 Critical equipment breakdown	導致停工/停產影響產品交期時通知。 Supplier shall notify customers of the situation if it leads to production shutdown or suspension.
材料/備品零件短缺 Material/spare parts shortage	導致停工/停產影響產品交期時通知。 Supplier shall notify customers of the situation if it leads to production shutdown or suspension.
資訊技術失效/遭受網路攻擊 IT failure/ cyber attacks	導致停工/停產影響產品交期時通知。 Supplier shall notify customers of the situation if it leads to production shutdown or suspension.
重大環保異常 Major Environmental Anomaly	環保處理系統異常或重大違規，導致停工/停產影響產品交期時通知。 Supplier shall notify customers of the situation if an anomaly or major violation occurs in the environmental processing system and causes production shutdown or suspension.

重大職災 Major Occupational Accident	因以下情事導致停工調查影響產品交期時通知。 <ul style="list-style-type: none"> <li>➢ 發生死亡災害、</li> <li>➢ 發生災害之罹災人數在三人以上、</li> <li>➢ 氨、氯、氟化氫、光氣、硫化氫、二氧化硫等化學物質之洩漏，發生一人以上罹災勞工需住院治療者、</li> <li>➢ 其他經勞動部指定公告之災害者。</li> </ul> Supplier shall notify customers of any situation listed below if it affects product delivery date: <ul style="list-style-type: none"> <li>➢ when death occurs;</li> <li>➢ when 3 or more persons are injured;</li> <li>➢ when injuries requiring hospitalization to 1 person or above occurs as the result of chemical substance leakage of ammonia, chlorine, hydrogen fluoride, phosgene, hydrogen sulfide, sulfur dioxide;</li> <li>➢ when any accident as specified and announced by Ministry of Labor occurs.</li> </ul>
